Installation & Operation


Electrical Connection:

- 1. Loosen the ten (10) M6 hexagon bolts with spring washers and nuts on the tank cover with a torque value of 7 N-m.
- 2. The entry hole of the tank is treaded with 3/4" NPT. Attach the tank to a suitable conduit.
- 3. Insert the wire from outside through the conduit and the entry hole of the tank, and then connect it to the terminal block.
- Introduce the wires of the branch circuit as follows: 4.

Black-wire connects to Line White-wire connects to Neutral Green-wire connects to Ground

5. Re-attach the tank cover by tightening the ten (10) M6 hexagon bolts with spring washers and nuts with a torque value of 7 N-m.

Check the tightness of the conduit and tank cover. 6.




Wall/Ceiling/Floor Mounting Bracket:


- 7. The mounting bracket is intended for wall/ceiling/floor mounting.
- 8. Position the mounting bracket and fix it with two (2) M6 and two (2) M8 hexagon bolts with spring lock washers.
- 9. Secure the wall/ceiling/floor mounting bracket to the structure by using screws (not provided). (Figure 1)
- 10. The luminaire can be adjusted facing down 90° from vertical = Lens horizontal facing down on ceiling position. (Figure 2).
- 11. The luminaire can be adjusted up and down by 45° on wall/floor position only. (Figure 3).

Pendant Mount:

- 12. The luminaire are installed with DN20 (3/4" NPT)
- 13. Fix the luminaire with M5 screws with torque value 4 N-m. (Figure 4)

Servicing

- To avoid personal injury, disconnect power to the light and allow the unit to cool down before performing maintenance.
- Perform visual, electrical, and mechanical inspections on a regular basis. The environment and frequency
 of use should determine this. However, it is recommended that checks be made at least once a year.
 Frequency of use and environment should determine this.
- The external glass should be cleaned periodically to ensure continued luminaire performance. Clean the glass with a clean, damp, non-abrasive, lint-free cloth. If this is not sufficient, use a mild soap or a liquid cleaner. Do not use an abrasive, strong alkaline or acid cleaner as damage may occur.
- Inspect the cooling fins on the luminaire to ensure that they are free of any contamination (i.e. excessive dust build-up). Clean with a non-abrasive cloth if needed.
- Mechanically check that all parts are properly assembled.
- Electrically check to make sure that all connections are clean and tight.
